Terms and Conditions:-

1. Rates should be quoted for a quantity of 1(one) each and cables/wires should be quoted per metre. The rates shall be inclusive of all taxes, duties, loading and unloading charges, transportation, accessories, installation charges and other incidental expenses and net for the work at the above mentioned sites.
2. The payment will be made as per the actual measurement as quantities deployed at the sites.
3. Payment will be released after the satisfactory supply, installation, testing and commissioning of the CCTV/Surveillance system keeping 10% as retention for the defect liability/warranty period.
4. The items supplied should have a warranty for a minimum period of 1(one) year and any service requirement needed within the warranty period has to be attended at the site.
5. GST Registration Certificate and PAN card are to be attached with the quotation.
6. The work shall be carried out in consultation with the Technical Branch of the office.
7. The materials used for the work should be from the attached list including necessary certifications and standards.
8. The office reserves all the rights to reject any or all the quotations with assigning and reason.
